Item 4 - Handicap Secretary Report - Tony Love

This has been quite a challenging year for my first one in this role, it started with trying to adopt a two division system for the society which was very challenging and after many calls/emails between myself and Andy P which resulted in two databases being built on HandicapMaster which unfortunately meant I was unable to have one back up database that could be shared between handicap committee in case issues with my laptop.

This also meant that with the first event at Mardyke Valley peoples handicaps were adjusted separately depending on what division they were in and after handicap cut or increased according to their score in each division, so after a discussion with handicap committee this was then put back to one which meant me stripping out all the scores for Mardyke and then reentering them as one thus cutting and increasing handicaps more fairly across all members dependant on their stableford points score across everyone. This also meant we were able to have a single back up database to be shared around in case of issues with my laptop.

We have also been looking into the new WHS system as to whether this can be adopted for our society this is also ongoing as at present the system we use can't cope with this and may need an upgrade which will be at a cost but we do have another option that if course has a slope rating and conversion chart this could be used to adapt each members handicap prior to the event so watch this space as it will be briefed out prior to adopting this process.
